Since 2008, Community Health & Dental Care ensures access to appropriate levels of care for all people in the service area regardless of their ability to pay. We accept most major Commercial, Medicare and Medicare supplement plans, Fee for Service Medicaid and Managed Care Medicaid plans and provides a health care discount for eligible uninsured and underinsured patients. For qualified patients receiving a 100% healthcare discount, the nominal fee for a medical/behavioral health/vision visit is \$20, \$35 for a dental visit and \$5 for a prescription! CHDC can offer the health care discount because we receive annual funding from our Federal partner, Health Resources and Services Administration (HRSA) since 2012 as a designated Federally Qualified Health Center.
