## COMMUNITY HEALTH & DENTAL CARE AWARDED BEHAVIORAL HEALTH EXPANSION GRANT

Pottstown – Community Health & Dental Care (CHDC) proudly announces it is the recipient of a Health Resources and Services Administration (HRSA) grant award to expand mental health and substance use disorder service throughout its service area in the tri-county region of southeastern Berks, western Montgomery, and northern Chester counties.

HRSA, an agency within the U.S. Department of Health and Human Services (HHS) awarded CHDC, along with 400 other community health centers across the country, to help increase access to behavioral health services. This award comes from the Biden-Harris announcement of its historic investment of \$240 million in funding to integrate mental health and substance use disorder treatment into primary care to more than 10 million patients across the country.

Bridgette McGivern, CEO of CHDC, recognized the great need for additional behavioral support services to address the growing mental health needs and substance use of opioids in the tri-county region. "More and more children and adults are suffering each day with anxiety, depression, opioid abuse, and I am so happy to receive this award to increase access to behavioral health services throughout our five CHDC locations! This includes virtual visits, making it easier for our patients to access these services as this grant will allow CHDC to hire more staff to meet these growing demands."

As a Federally Qualified Health Center (FQHC), CHDC is a true medical home offering access to quality, affordable healthcare services to all individuals regardless of insurance status or ability to pay. Integrated behavioral health is available to all established medical patients. Integrated behavioral health is a holistic approach to behavioral health to include mind and body. By working with a CHDC medical provider, our licensed Behavioral Health team provides short-term brief solution-focused sessions, goal setting and guidance, and referrals to outpatient treatment. Additionally, patients are screened for depression and anxiety at all patient visits to help provide the resources and tools to fight mental illness.

In 2016, CHDC was designated as a PA Center of Excellence which helps individuals recover from addiction and provides support to move forward. CHDC earned its designation from the Department of Human Services to be utilized by anyone with a current or previous diagnosis of opioid use disorder. CHDC uses use both internal and external resources and referrals to provide the best addiction treatment services. Each person gets their own Care Manager, who coordinates the many aspects of a recovery program. Internally, CHDC refers to medication-assisted treatment, medical services, and referrals to behavioral health counseling. Externally, CHDC partners with organizations such as 12-Step Meetings, Sober Living opportunities, and more to provide care outside its office.
